

FOREIGN CORPORATION  
APPLICATION FOR CERTIFICATE OF AUTHORITY RETURN

The application submitted to this office for a Certificate of Authority is being returned.

Pursuant to O.C.G.A. §14-2-1501(a), "a foreign corporation may not transact business in this state until it obtains a certificate of authority from the Secretary of State." O.C.G.A. §14-2-122(7) sets out a civil penalty of \$500 "for each year or part thereof during which a foreign corporation transacts business in this state without a certificate of authority."

You have stated on Form A100F, the Application for Certificate of Authority filed with this office, that the corporation commenced business in Georgia on 11/1/89. Therefore, the enclosed documents should be returned with a check payable to the Secretary of State in the amount of 1,000.00. This total represents \$500 for each year during which the corporation was not qualified, plus annual registration fees which would have been assessed during those years.

These penalties are assessed pursuant to provisions of the Georgia Business Corporation Code, without discretion by the Secretary of State.
