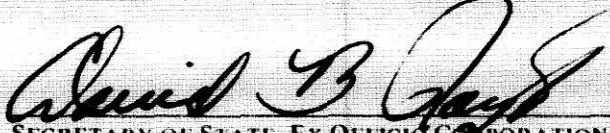

ARTICLES OF INCORPORATION
OF
ALPHA INFORMATION SYSTEMS, INC.

I.

The name of the corporation is "Alpha Information Systems, Inc."

II.

The corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

III.

The corporation shall have perpetual duration.

IV.

The corporation is a corporation for profit and is organized for the following purposes:

for the sale of computer hardware and software;

to engage in any lawful business or activities related thereto; and

to engage in any lawful act or activity for which corporations may be organized under the Georgia Corporation Code.

V.

The corporation shall have authority, acting by its board of directors, to issue not more than 10,000 shares of a common class having no par value.

VI.

The corporation shall not commence business until it shall have received consideration of not less than \$500 in value for the issuance of its shares.

VII.

The shareholders of the corporation shall not have any preemptive rights to acquire any unissued shares of the corporation.

VIII.

The address of the initial registered office of the corporation is 200 Derby Drive, Fayetteville, Fayette County, Georgia 30214, and the initial registered agents of the corporation at such address are Mr. James L. Seigle, Mr. Thomas M. Turner, and Mr. Clark W. Schadle.

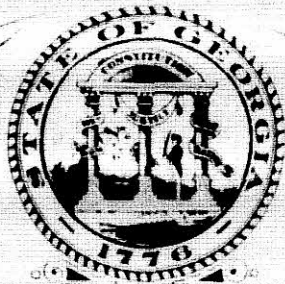
