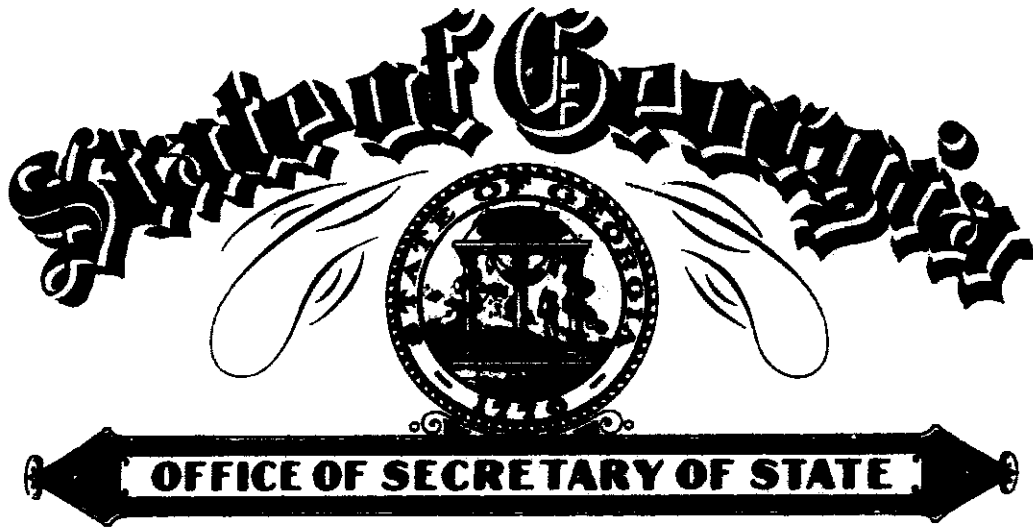

The Articles of Incorporation of LAW OFFICES OF KING & KING, P.C. are as follows:

I.

The name of the corporation is LAW OFFICES OF KING & KING, P.C.

II.

The corporation shall have perpetual duration.

III.

The corporation is organized under the Georgia Business Corporation Code for the following purposes:

To engage in every phase and aspect of the practice of law, and to sell, rent, lease, or purchase any property whether real or personal, necessary or appropriate to the rendering of such services.

To own real and personal property necessary or appropriate for the rendering of the services authorized by this Article and to invest the funds of this Corporation in real estate, mortgages, stocks, bonds, or any other type of investment whatsoever.

To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of the purposes and objects enumerated

in these Articles of Incorporation or any amendments thereof, necessary or incidental to the protection and benefit of this Corporation, and, in general, either alone or in association with other associations, corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or objects of this Corporation; and to enter into any other lawful businesses from time to time without limitation.
