ARTICLES OF INCORPORATION

OF

PACE CONSULTING, INC.

I.

The name of the corporation is "Pace Consulting, Inc".

II.

The corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

III.

The corporation shall have perpetual duration.

IV.

The corporation is a corporation for profit and is organized for the following purposes:

- 1) Business Consulting
- 2) Municipal Consulting and to engage in any lawful business or activities related thereto; and to engage in any lawful act or activity for which corporations may be organized under the Georgia Corporation Code.

V.

The corporation shall have authority, acting by its board of directors, to issue not more than 1000 shares of a common class having a par value of no par value per share.

VI.

The corporation shall not commence business until it shall have received consideration of not less than \$500 in value for the issuance of its shares.

VII.

The shareholders of the corporation shall not have any preemptive rights to acquire any unissued share of the corporation.



It shall not be necessary to set forth in the articles of incorporation any of the corporate powers enumerated in section 14-2-21 of the Georgia Corporation Code.

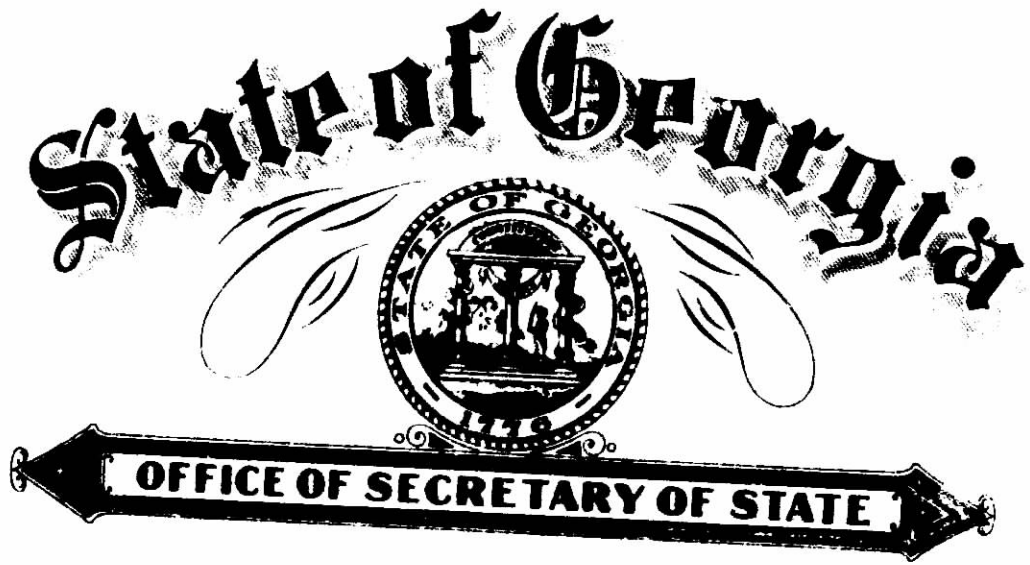
