ARTICLE I

NAME OF CORPORATION

The name of the corporation is Atlanta Plastic Equipment, Inc.

ARTICLE II

PURPOSE

The corporation is a corporation for profit, and is organized to engage in any lawful business or activity for which corporations may be organized under the Georgia Business Corporation Code, and to exercise all the rights, privileges, immunities and authority granted to or exercised by a business corporation under the laws of the State of Georgia now in effect or which will become in effect during the existence of this corporation.

ARTICLE III

AUTHORIZED CAPITAL STOCK

The corporation shall be authorized to issue one hundred thousand (100,000) shares of common stock with a par value of \$.01 per share.

ARTICLE IV

REGISTERED OFFICE

ARTICLE VII

CORPORATE POWER

In accordance with the applicable provisions of the Georgia Business Corporation Code, the corporation shall have the power, acting through its Board of Directors, to make distributions of

its assets to its shareholders out of its capital surplus and to acquire its own shares out of its unreserved and unrestricted capital surplus available thereto.

ARTICLE VIII

LIMITATION OF DIRECTOR LIABILITY

To the fullest extent permitted by the Georgia Corporation Code (as now in existence or hereafter amended), a director of the corporation shall not be liable to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director. Any repeal or modification of this Article VIII shall not adversely affect any right or protection of a director of the corporation existing immediately prior to such repeal or modification.




