NOW COME C. Douglas Collins, Michael Worthington, and Gary E. Klingler, the incorporators, acting by and through their attorney, and file these Articles of Incorporation of a business corporation under the Georgia Business Corporation Code, and show the following:

1.

NAME AND ADDRESS

The name and address of the Corporation are: ROLLETEC, INC., 103 Prior Station Rd., Cedartown, Georgia 30125. The Certificate of Name Availability issued by the Secretary of State is attached hereto.

GEORGIA BUSINESS CORPORATION CODE

The corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

DURATION

The period of duration of the corporation shall be perpetual.

PURPOSES
