ARTICLES OF INCORPORATION
OF
OCONEE HOME MAINTENANCE, INC.

1.

The name of the Corporation is Oconee Home Maintenance, Inc.

2.

The Corporation shall have perpetual duration.

3.

The Corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

4.

The Corporation is a Corporation for profit and is organized for the following general purposes:

(a) To engage in and operate a business for home maintenance.
b) To engage in any lawful business or activity related thereto.

(c) To engage in any lawful act or activity for which corporations may be organized under the Georgia Business Corporation Code.

5.

The maximum number of shares of capital stock that the Corporation shall be authorized to have outstanding at any time shall be 1000 shares of common stock of no par value.

6.

The Corporation shall not begin business until it has received consideration of a fixed value, which shall not be less than \$500.00, for the issuance of its shares of common stock.

The Board of Directors of the Corporation may authorize the issuance of bonds, debentures and other evidences of indebtedness of the Corporation and may fix all the terms thereof, including, without limitation, the convertibility thereof into shares of stock of the Corporation of any class, or any series of the same class.

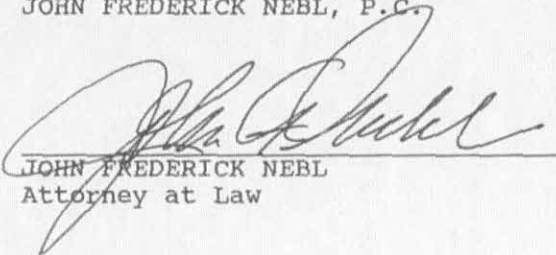

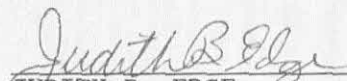
