AMENDMENT TO ARTICLE OF INCORPORATION FOR GLOBAL CARE CENTERS, INC.

1. Notwithstanding any other provision of these Articles, Global Care Centers, Inc. shall not carry on any other activities not permitted to be on
 - (a) By an organization exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law) or
 - (b) By an organization contributions to which are deductible under 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law.

Upon winding up and dissolution of Global Care Centers, Inc., after paying or adequately providing for the debts and obligations of the Global Care Centers, Inc., the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and or scientific purposes and which has established its tax exempt status under section 501 (c) (3) of the Internal Revenue Code or shall be distributed to Federal, State or Local government for a public purpose.

2. Global Care Centers, Inc. is not expressly empowered to engage, otherwise than as in substantial part of its activities, in activities that are in themselves are not in furtherance of one or more exempt purposes and
3. Global Care Centers, Inc. assets will be dedicated to a exempt purpose within IRS 501 (c) (3).






