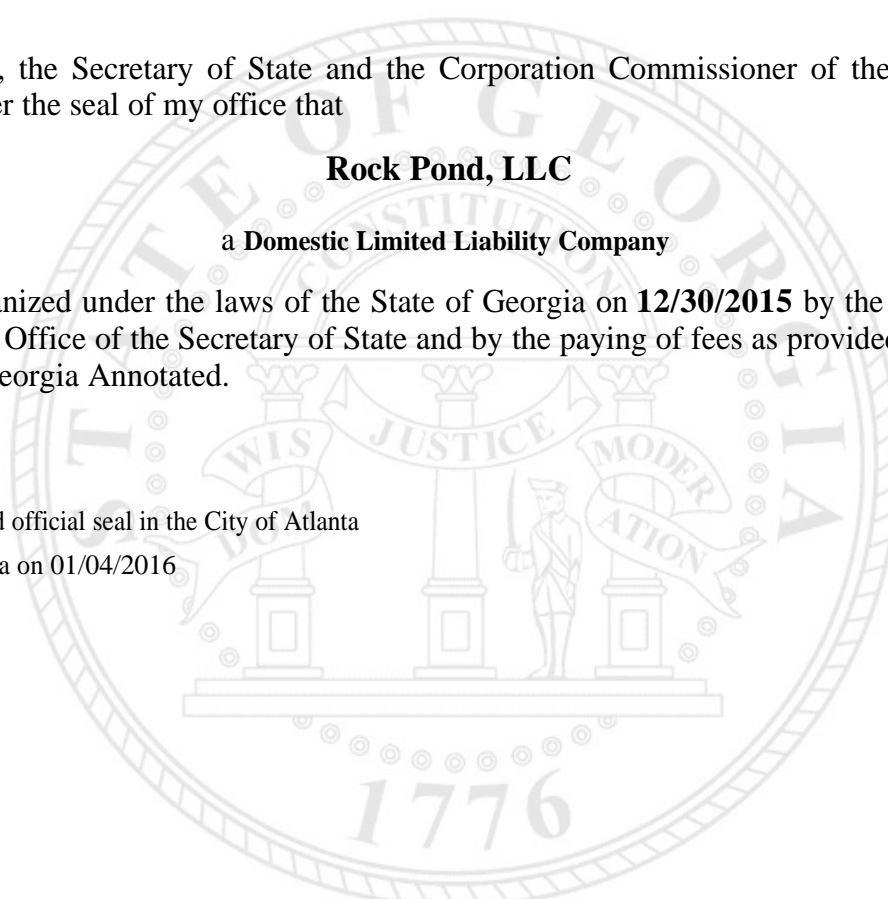

OPTIONAL PROVISIONS

Management Management of the business and affairs of the Company shall be vested in the managers, and, subject to any provisions of a written Operating Agreement, the managers shall have the right and authority to manage the affairs of the Company and to make all decisions with respect thereto. Unless otherwise provided in a written Operating Agreement, managers: Shall be designated, appointed, elected, removed, or replaced by the affirmative vote of members who have contributed more than fifty (50) percent of the capital of the Company; Need not be members of the Company or natural persons; and Unless they have been earlier removed or have earlier resigned, shall hold office until their successors shall have been elected and qualified. Indemnification Subject to the provisions of subsection (4)(A) of Section 14-11-305 of the Georgia Limited Liability Company Act, or provisions of a written Operating Agreement, the Company shall indemnify and hold harmless any and all members or managers from and against any and all claims and demands whatsoever arising in connection with the Company.
