**ARTICLES OF INCORPORATION
OF
NAM DAE MUN FOUNDATION, INC.**

**ARTICLE ONE
NAME**

The name of the corporation is Nam Dae Mun Foundation, Inc. (the "*Corporation*").

**ARTICLE TWO
DURATION**

The duration of the Corporation is perpetual.

**ARTICLE THREE
PURPOSE OF THE CORPORATION**

The Corporation is a non-profit corporation organized pursuant to the Georgia Nonprofit Corporation Code, Chapter 3 of Title 14 of the Official Code of Georgia Annotated, as amended (the "*Code*"). The Corporation is organized and is to operate as a non-profit organization, and it is intended that the Corporation will qualify at all times as an organization exempt from Federal income tax under Section 501(a) of the Internal Revenue Code of 1986, as amended, by qualification as an organization described in Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE FOUR
INITIAL REGISTERED OFFICE AND AGENT**

The street address and county of the initial registered office of the Corporation shall be at 1649 International Court, Norcross, Georgia 30093. The initial registered agent of the Corporation at such address shall be Alice Kim.

**ARTICLE FIVE
INCORPORATOR**

The name and address of the incorporator is Tai Hyun Shin, Esq., 201 17th Street NW, Suite 1700, Atlanta, Georgia 30363.

**ARTICLE SIX
PRINCIPAL OFFICE**

The mailing address of the initial principal office of the Corporation is 1649 International Court, Norcross, GA 30093.

**ARTICLE SEVEN
MEMBERS**

The Corporation shall not have members, as that term is defined in Section 14-3-140(22) of the Code.

**ARTICLE EIGHT
BOARD OF DIRECTORS**

The direction and management of the affairs of the Corporation and the control and disposition of its properties and funds shall be vested in a Board of Directors composed of such number of persons and elected as provided in the bylaws of the Corporation. The initial directors of the Company and their address shall be:



**ARTICLE NINE
INDEMNIFICATION**

The Corporation shall indemnify to the fullest extent permitted by the laws of the State of Georgia any person who has been made, or is threatened to be made, a party to an action, suit, or proceeding, whether civil, criminal, administrative, investigative, or otherwise (including an action, suit or proceeding by or in the right of the Corporation), by reason of the fact that the person is or was a director or officer of the Corporation, or serves or served at the request of the Corporation as a director, or as an officer, or as a fiduciary of an employee benefit plan, of another corporation, partnership, joint venture, trust or other enterprise. In addition, the Corporation shall pay for or reimburse any expenses incurred by such persons who are parties to such proceedings, in advance of the final disposition of such proceedings, to the full extent permitted by the law.


