ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of the Corporation is TEN THIRTY-ONE REALTY CORP.

ARTICLE IX

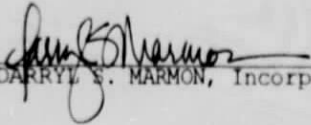
