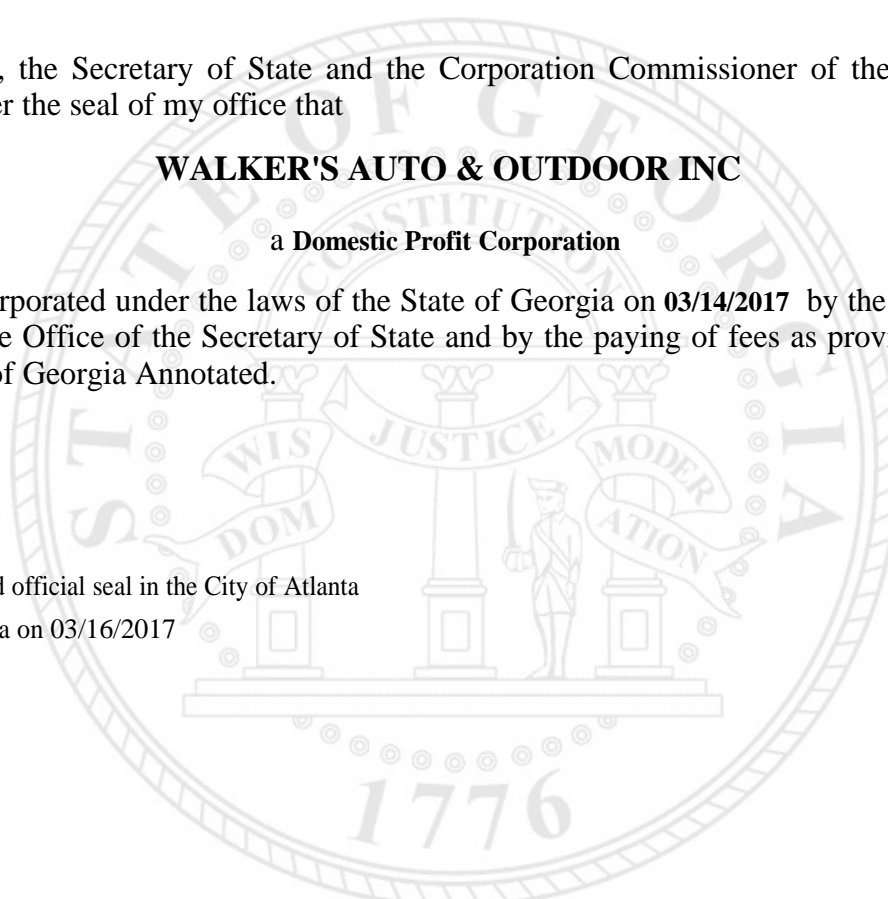

D. O.C.G.A. § 14-2-202(B)(5) IS INCORPORATED HEREIN BY REFERENCE. DIRECTORS SHALL HAVE THE MAXIMUM DISCRETION AS SET FORTH IN O.C.G.A. § 14-2-202(B)(5).
