**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF**

MICROSIGHT TRAINING SOLUTIONS, INC.

Pursuant to § 14-3-1001 of the Georgia Code, Microsight Training Solutions, Inc., a Georgia nonprofit corporation, hereby submits the following Amended and Restated Articles of Amendment:

Article 1: Name of the Corporation

The name of the corporation is Microsight Training Solutions, Inc. (the "**Corporation**").

Article 2: Corporate Purpose

The purpose of the Corporation is to engage in any and all lawful business for which corporations may be incorporated under the Code.

Article 3: Authorized Shares

The Corporation is authorized to issue a total of 1,000 shares of the same class with a par value of \$0.001 per share.

The Board of Directors is authorized to establish one or more classes or series of shares of the Corporation's stock, setting forth the designation of each such class or series, and fixing the preferences, limitations, and relative rights of each such class or series.

Article 4: Initial Registered Office and Agent
