

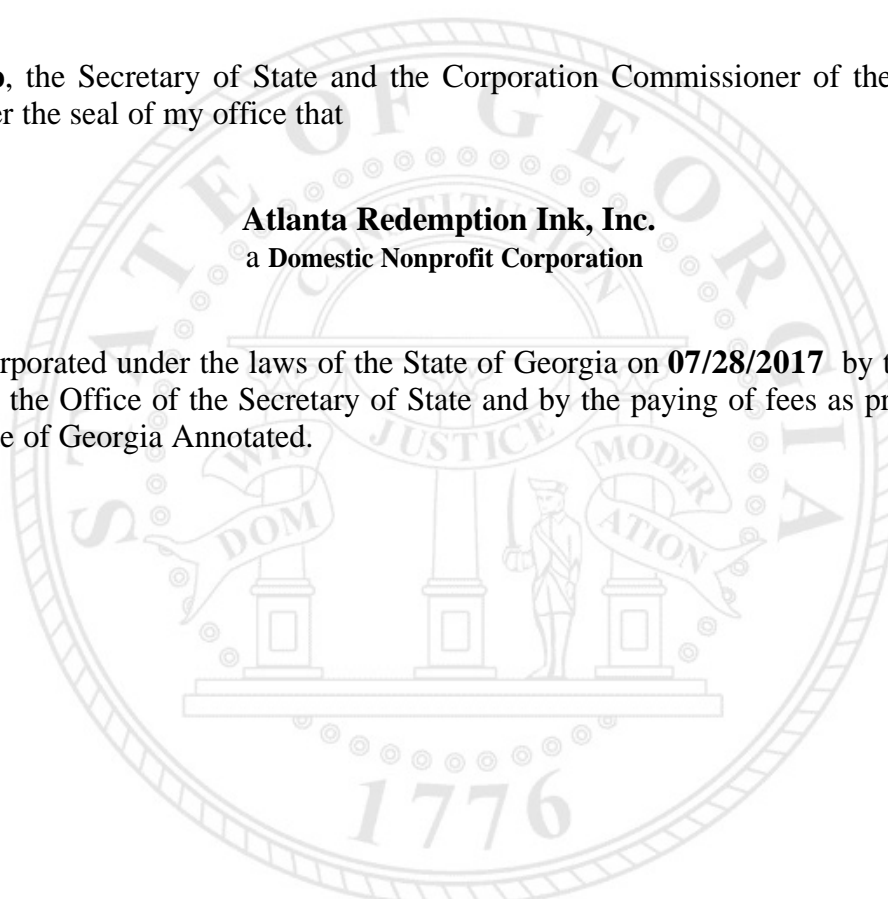

ARTICLES OF INCORPORATION
OF

I

The name of the corporation is Atlanta Redemption Ink, Inc.

II.

Atlanta Redemption Ink, Inc. is organized pursuant to the Georgia Nonprofit Corporation Code. We are a religious association, whose bylaws and structure are for the promoting of the Christian faith. Mission is to restore dignity to survivors who have been left with physical markings from brandings, physical and drug abuse and offer tattoo covers or debranding removals . Exchanging marks of hurt for hope.

(A) The purposed for which this corporation Atlanta Redemption Ink, Inc. was formed and is exclusively religious and educational within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

(B) Not withstanding any other provision of these articles, Atlanta Redemption Ink, Inc. shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

(C) Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax law or shall be distributed to the federal government or to a state or local government for public purposes. Assets not so disposed of by Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said court shall determine, which are organized and operated exclusively for such purposes.

Establishment of Members:


