TWO: The Corporation will commence business immediately upon the filing of these Articles of Incorporation with the Georgia Secretary of State and shall have perpetual duration. THREE: The Corporation is organized for the purpose of carrying on any lawful business for pecuniary gain and profit and may do all things necessary and proper for the accomplishment of any of the purpose of the Articles of Incorporation and may buy, own, design, manufacture, distribute, lease, finance, sell, or otherwise dispose of, deal in or with any types of property, both real and personal, and in doing so may act as principal or agent, as a member of a partnership or joint venture, agreement, as licensor or licensee, upon commission or otherwise. Said Corporation may enter into any lawful business from time to time, without limitation. FOUR: Liability of Directors The personal liability of the directors of the Corporation is hereby eliminated to the fullest extent permitted by Section 202(b)(4) of the Georgia Business Corporation Code (O.C.G.A. §14-2-202(b)(4)), as the same may be amended from time to time. FIVE: Indemnification The Corporation shall, to the fullest extent permitted by Section 850, et seq. of the Georgia Business Corporation Code (O.C.G.A. §14-2-850, et seq.), as such may be amended from time to time, indemnify all persons whom it may indemnify pursuant thereto. SIX: A. This Corporation shall be entitled to all rights, privileges, and immunities and shall be subject to the obligations and liabilities of corporations organized for profit under the Business Corporation Code, as previously existed, now exists, and may hereafter be amended. B. This corporation shall be authorized to issue its stock in accordance with appropriate laws and regulations so as to have stock issued as Section 1244 stock in accordance with the Internal Revenue Code.
