ARTICLES OF INCORPORATION
OF
FRIENDS OF GEORGIA LIBRARIES FOR ACCESSIBLE STATEWIDE
SERVICES - ATLANTA, INC.

The undersigned, acting as the incorporators, desiring to form a nonprofit corporation, adopt the following Articles of Incorporation for such corporation:

1.

The name of the corporation is "FRIENDS OF GEORGIA LIBRARIES FOR ACCESSIBLE STATEWIDE SERVICES - ATLANTA, INC.".

2.

The corporation shall have perpetual duration.

3.

The corporation is organized as a nonprofit corporation pursuant to the Georgia Nonprofit Corporation Code.

4.

The corporation is organized exclusively for charitable and educational purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

5.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation

shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in paragraph 4 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

6.

Upon the dissolution of this corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or to the State of Georgia or a local government, for a public purpose.

7.

The street address of the registered office is 55 Park Place NE, Suite 300, Atlanta, GA 30303. The registered agent at such address is Beverly Williams. The county of the registered office is Fulton County.




