**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION**

PEACOCK HOLDINGS, LLC (the "Company"), a Georgia limited liability company formed pursuant to those certain Articles of Organization of Peacock Holdings, LLC (the "Original Articles"), filed of record with the Secretary of State on January 25, 2006, does hereby amend the Original Articles pursuant to O.C.G.A. § 14-11-210 as follows:

ARTICLE ONE

The Company hereby deletes Article Second of the Original Articles and restates said Article Second to read as follows:

"The term of the Company shall commence as of the effective formation date with the Georgia Secretary of State and continue in perpetuity unless earlier dissolved in accordance with the provisions of this Operating Agreement or the Georgia Act."

ARTICLE TWO

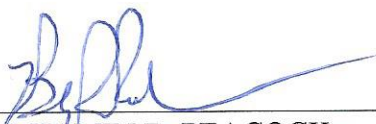
The Company hereby deletes Article Sixth of the Original Articles and restates said Article Sixth to read as follows:
