

Articles of Incorporation

The Name of the Corporation:

First United Pentecostal Church, Home of "The Pentecostals of Brunswick", Inc.

The corporation is organized pursuant to the Georgia Nonprofit Corporation Code.

Optional Provisions:

The corporation is a non-profit corporation and is organized and operated exclusively for religious purposes within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law in order to:

1. Magnify the life and work of the Lord Jesus Christ, and to accomplish this, it is the intent of this body to give guidance and instruction in the promotion and renewal of the Christian faith to those persons, groups, or churches who desire our help;
2. To teach, evangelize, exhort, provide spiritual counsel, and guide willing persons into an understanding of the reception and practice of the life of Jesus Christ as set forth in the Holy Scriptures;
3. Minister the Word of God;
4. Promote and encourage, through the ministries of the organization, cooperation with other organizations ministering within the community;
5. Spread the Word of the gospel by ministering to all through radio, television, and other forms of mass media;
6. To maintain local ministry and missionary facilities;
7. To provide Sunday School or any other type of school for the religious and educational instruction of the young, as well as for adults, under the direction of the ministry.

To engage in any lawful business or activities related thereto;

To engage in any lawful act of activity for which corporations may be organized under the Georgia Non-Profit Corporation Code.

The Affairs of the Corporation shall be in the hands of its Board of Directors,

Which shall consist of not less than three (3) individuals. The directors shall be elected in the manner provided in the By-laws of the Corporation.

Notwithstanding any provision of these Articles, the purposes of this Corporation are limited to those described in section 501 (c) (3) of the Internal Revenue Service Code of 1954 or any other corresponding provision of any future United States Revenue Law.

The address of the initial registered office of the corporation is P.O. Box 2176 Brunswick, GA 31521 and the initial registered agent of the corporation at such address is Willene Smith.

The mailing address of the corporation shall be P.O. Box 2176 Brunswick, GA 31521.

Upon dissolution of the corporation, all funds, property and other assets of the corporation that are not necessary to discharge its legal debts and obligations shall be distributed exclusively to one or more exempt organizations within the meaning of Section 501 (c) (3) of the code.
