**ARTICLES OF INCORPORATION  
OF  
WILDCAT FUNDING, INC.**

Pursuant to the provisions of the Georgia Business Corporation Code, the undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation.

**Article 1 Entity Name and Type**

The name of the corporation **WILDCAT FUNDING, INC.** (the "**Corporation**"). The Corporation is a for-profit corporation and shall have perpetual duration. The mailing address of the principal office of the Corporation is 675 Progress Center Ave, Ste A, Lawrenceville GA 30043.

**Article 2 Registered Agent and Registered Office**

The name of the initial registered agent of the Corporation is Corporation Service Company.

The street address and the county of the initial registered office of the Corporation is 675 Progress Center Ave, Ste A, Lawrenceville GA 30043, Gwinnett County.

**Article 3 Incorporator**

**Article 4 Authorized Shares**

The total number of shares the Corporation is authorized to issue is 1,000 shares of common stock. The par value of each of the authorized shares is \$0.01 per share.

**Article 5 Mailing Address**

**Article 6 Purpose**

The purpose for which the Corporation is formed is for the transaction of any and all lawful business for which a for-profit corporation may be organized under the Georgia Business Corporation Code.

### **Article 7 Indemnification**

The Corporation shall, to the fullest extent permitted by the provisions of the Georgia Business Corporation Code, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and any indemnification effected under this provision shall not be deemed exclusive of rights to which those indemnified may be entitled under any Bylaw, vote of shareholders or disinterested directors, or otherwise, both as to action in their official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person

### **Article 8 Director Liability**

The personal liability of the directors of the Corporation is hereby eliminated to the fullest extent permitted by the provisions of the Georgia Business Corporation Code, as the same may be amended and supplemented.

### **Article 9 Publishing**

This Article constitutes an undertaking by the corporation to publish a notice of the filing of these Articles of Incorporation as required by the provisions of subsection (b) of Section 14-2-201.1 of the Georgia Business Corporation Code.

### **Article 10 Effectiveness of Filing**

The effective date of these Articles of Incorporation shall be the date hereof.

### **Article 11 Execution**

The undersigned affirms that the person designated as registered agent has consented to the appointment. The undersigned signs this document subject to the penalties imposed by law for the submission of a materially false or fraudulent instrument and certifies under penalty of perjury that the undersigned is authorized to execute the filing instrument.
