ARTICLES OF AMENDMENT IGLESIA NUEVO COMIENZO COLUMBUS, INC.

Article 1

The Name of this corporation shall be Iglesia Nuevo Comienzo Columbus, INC.
Date of adoption: May 13, 2021.

Article 2

This corporation is organized pursuant to the Georgia Nonprofit Corporation Code.
Date of adoption: May 13, 2021.

Article 3

The purposes for which this corporation is formed are:

1. The specific and primary purposes are:
 - A. To establish and maintain a place of worship to Almighty God and the promotion of Christian fellowship and edification.
 - B. To function as a local Assembly of God in harmony with the Constitution and Bylaws of the General Council of the Assemblies of God, Springfield, Missouri, and the Southern Latin District Council of the Assemblies of God, INC., Marietta, Georgia.
2. The General purposes and powers are:
 - A. To establish and maintain such departments and institutions as may be thought advisable for the pursuance of its work.

B. To contract and be contracted with.

C. To have and use a corporate seal.

D. To purchase, receive, possess, and dispose of such real and personal property as may be necessary or convenient to carry out the object of said corporation.

E. To make bylaws, not inconsistent with any existing civil law, for the government of its affairs and the management of its property; and now or hereafter may be permitted by law for corporations of this character. Date of adoption: May 13, 2021.

Article 4

The street address of the registered office is 8100 Cooper Creek Rd., Columbus, GA 31909, USA. The registered agent is Gustavo Serra-Sanchez, address is 102 Moss Dr. Columbus, GA 31904, USA Muscogee County. Date of adoption: May 13, 2021.

Article 6

The principal mailing address is P.O. Box 4093 Columbus, Georgia 31914 Date of adoption: May 13, 2021.

Article 7

This corporation shall have perpetual duration and shall have members in addition to its directors. Date of adoption: May 13, 2021.

Article 8

The authorized number and qualifications of the members of the corporation; the different classes of membership and their liability to dues and assessments and the method of collection thereof shall be set forth in the bylaws. The method of electing the directors shall be set forth in the bylaws. Date of adoption: May 13, 2021.

Article 9

This corporation shall have the right to use the name “Assembly of God” or “Assemblies of God” only so long as it shall be cooperative unit of the Southern Latin District of the Assemblies of God, INC. and such Council shall have the right to restrain the use of said name in an action at law and in equity in the event this corporation at any time ceases to be a cooperative unit. Date of adoption: May 13, 2021.

Article 10

This corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations

that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code or the corresponding section of future tax code. Date of adoption: May 13, 2021.

Article 11

NO part of the earnings of this corporation shall inure to the benefit of or be distributed to its members, trustees, officers, or other private persons, exempt this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of this corporation. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and this corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue code or the corresponding section of the future federal tax code or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue code or the corresponding section of the future federal tax code. Date of adoption: May 13, 2021.


Article 12

Upon the termination and dissolution of this corporation, after paying or adequately providing for the debts and obligations of this corporation, the remaining assets shall be distributed to the Southern Latin District of the Assemblies of God, Inc., a Georgia nonprofit corporation; or in the event that said Southern Latin District of the assemblies of God inc. is not then in existence or is not exempt from federal income tax under section 502 (c)(3) of the Internal Revenue code or the corresponding section of the future federal tax code, then said assets shall be distributed to the General Council of the assemblies of God, Missouri nonprofit corporation with headquarters in Springfield, Missouri; or in

the event that said The General Council of the assemblies of God is not then in exitance or is not exempt from federal income tax under section 501(c)(3) of the internal Revenue code of the corresponding section of the future federal tax code, then said assets shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious and charitable purposed in harmony with the purposes of the above-named corporations and which is exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding section of the future federal tax code. Any such assets not so disposed of shall be disposed of by Court of competent jurisdiction of the county in which the principal office of this corporation is then located, in accordance with this article. Date of adoption: May 13, 2021.
