ARTICLES OF INCORPORATION
OF
SOURCE ONE SERVICES, INC.

1.

The name of the corporation is "SOURCE ONE SERVICES, INC".

2.

The corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

3.

The corporation shall have perpetual duration.

4.

The corporation is a corporation for profit and is organized for the following purposes:

To provide a service of Technical Assistance and Sales of low voltage equipment in any lawful business or activities related thereto; and to engage in any lawful act or activity for which corporations may be organized under the Georgia Corporation Code.

5.

The corporation shall have authority, acting by its board of directors, to issue not more than 10,000 shares of a common class having a par value of \$1.00 per share.

6.

The corporation shall not commence business until it shall have received consideration of not less than \$500.00 in value for the issuance of its shares.

7.

The shareholders shall have full preemptive rights to acquire any unissued or Treasury shares of the corporation.

8.

The original principal office and the address of the initial principal office and the initial registered office of the corporation is 6109 Zachary Drive, Norcross, (Gwinnett County), Georgia 30093, and the initial registered agent at said address is Dwain Fitzpatrick.

9.

The number of directors constituting the board of directors shall be fixed by by-law. The initial board of directors shall consist of one member who is Dwain Fitzpatrick who resides at 6109 Zachary Drive, Norcross, Georgia 30093.

10.

These articles may be amended in the manner authorized by law at the time of amendment.

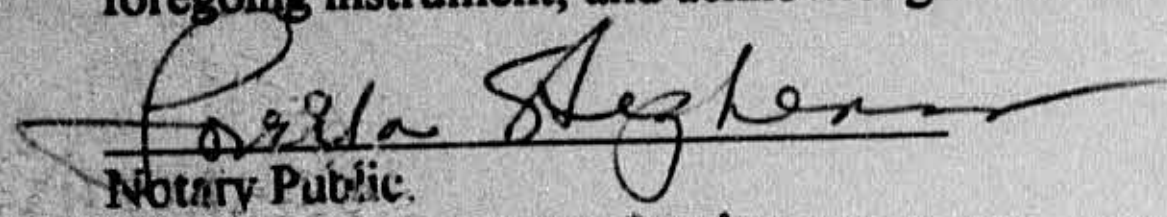
