





ARTICLES OF INCORPORATION OF

I.

The name of the corporation shall be: THE CREATIVE NETWORK, INC.

II.

The corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

III.

The corporation shall have perpetual duration.

IV.

The corporation is a corporation for profit and is organized for the following purposes:

(1) To render advertising, marketing, design, and consulting services to both individuals and business enterprises, as well as, to act as a referral service by referring individuals and business enterprises in need of the herein described services to third party advertisers, marketing agents, designers, and consultants.
