ARTICLES OF INCORPORATION
OF
ABLE PLUMBING COMPANY, INC.

I.

The name of the corporation is:

ABLE PLUMBING COMPANY, INC.

II.

The Corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

III.

The Corporation shall have perpetual duration.

IV.

The object of the Corporation is pecuniary gain and profit. The Corporation is formed for the purpose of the transaction of any or all lawful business for which corporations may be now or hereafter incorporated under the Georgia Business Corporation Code and any other lawful business which the Board of Directors of the Corporation from time to time may authorize.

In furtherance of, and not in limitation of, the general powers conferred by the laws of the State of Georgia and the objects and purposes herein set forth, it is expressly provided that to the extent as a corporation organized under the Georgia Business Corporation Code may now or hereafter lawfully do, the Corporation shall have the power to do (either as principal or agent and either alone or in connection with other corporations, firms or individuals) any and all things necessary, suitable, convenient or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of the Corporation or to enhance the value of its properties; and in general to do any and all things and exercise any and all powers, rights and privileges which a corporation may now or hereafter be authorized to do or to exercise under the Georgia Business Corporation Code or under any act amendatory thereof, supplemental thereto or substituted therefor.

The foregoing provisions of this Article IV shall be construed both as purposes and powers and each as an independent purpose and power. The foregoing enumeration of specific purposes and powers herein specified shall, except when otherwise provided in this Article IV, be in no way limited or restricted by reference to, or inference from the terms of any provision of

this or any other article of these Articles of Incorporation.

V.

The aggregate number of shares which the Corporation shall have authority to issue is 10,000, all of which shall be common shares of \$1.00 par value per share.

VI.

Shares of the Corporation may be issued by the Corporation for such consideration, not less than the par value thereof, as shall be fixed from time to time by the Board of Directors.

VII.

The Corporation shall be entitled to purchase its own shares out of its unreserved and unrestricted earned and capital surplus available therefor.

VIII.

The Corporation shall be entitled to distribute a portion of its assets to its shareholders out of capital surplus available therefor.

IX.

The Corporation shall not commence business until it shall have received \$500.00 in payment for the issuance of shares of stock.

X.

No shareholder shall have any preemptive right to subscribe for or to purchase any shares or other securities issued by the Corporation.

XI.

The initial registered office of the Corporation is located at 573 Martin Road, Stone Mountain, Georgia, 30088, and its initial registered agent at such address is Melvin Claude Atha.

XII.

The initial Board of Directors shall consist of one member whose name and address is as follows:


