ARTICLES OF INCORPORATION

I.

The name of the corporation is "Label Source, Inc."

II.

The Corporation shall have perpetual duration.

III.

The Corporation is organized pursuant to the provisions of the Georgia Business Corporation Code and is organized for the following purposes: to engage in any lawful activity not specifically prohibited to corporations under the laws of Georgia or the United States, including but not limited to engaging in the business of selling Flexographic, Silk Screened, Hot Stamped, and Rotary Letterpress labels and forms.

IV.

The Corporation shall have authority to issue not more than 100,000 shares of common stock of \$.10 par value.

V.

The Corporation shall not commence business until it shall have received not less than \$500.00.

None of the holders of shares of common stock shall be entitled as a matter of right to purchase, subscribe for or otherwise acquire any new or additional shares of stock of the Corporation of any class or any options or warrants to purchase, subscribe for or otherwise acquire any such new or additional shares, or any shares, evidences of indebtedness, or other securities convertible into or carrying options or warrants to purchase, subscribe for or otherwise acquire any such or new additional shares.

X.

The Board of Directors of the Corporation may, from time to time at its discretion, distribute a portion of its assets to its shareholders out of the capital surplus of the Corporation.

XI.
