ARTICLES OF INCORPORATION OF
"MT. CALVARY ASSOCIATION
OF
PRIMITIVE BAPTISTS, INC.

I.

The name of the Corporation is "MT. CALVARY ASSOCIATION OF PRIMITIVE BAPTISTS, INC.".

II.

The Corporation shall have perpetual duration.

III.

The Corporation is a non-profit Corporation and is created under the Georgia Non-Profit Corporation Code and is organized for the following purposes: To promote the spread of the Gospel throughout the State, Nation and World; to assist member Churches and their representatives in spreading the gospel; to assist member Churches and their representatives in spreading the beliefs and principles of the Association contained in the twelve Articles of Faith upon which the Association was constituted and for which said Association earnestly contends and believes; to cooperate with all public, private and religious agencies and professional groups in the furtherance of these ends.

IV.

The Corporation shall have no capital stock. Its membership shall be composed of the incorporators together with persons qualifying under the rules of eligibility set forth in the by-laws.

V.

In the event of dissolution of the Corporation, all assets and properties of the Corporation will be paid or conveyed to the member Churches.

VI.

The Corporation shall have all of the powers enumerated in Chapter 22-22 of the Code of Georgia as the same may now be in force and as may be hereinafter amended, together with all other and further powers as may be allowed under the laws of Georgia, generally.

VII.

The initial registered office of the Corporation and its registered agent for service is as follows:

The initial Board of Directors shall consist of six members who are: Elder Joseph Crawford, 1984 Shirley St., S.W. Atlanta, Georgia; Elder H. G. Terry, 2043 Lilac Lane, Decatur, Georgia; Elder A. D. Lawson, Route 4, Box 13, Eatonton, Georgia; Deacon Henry Worthy, 1720 Terry Mill Road, Atlanta, Georgia; Deacon A. D. Williams, Sr., Route 4, Box 113 A, Eatonton, Georgia; and Deacon Dan Sneed, 812 Berley Street, SW, Atlanta, Georgia, who shall hold office until election of permanent Directors pursuant to the by-laws.

IX.

The Incorporators are the same six persons named in the paragraph immediately preceding.

X.

It is intended that this Corporation shall conduct its operations so as to qualify as a ~~tax~~ exempt organization under the provisions of the Inter Revenue Code of 1954, as amended.

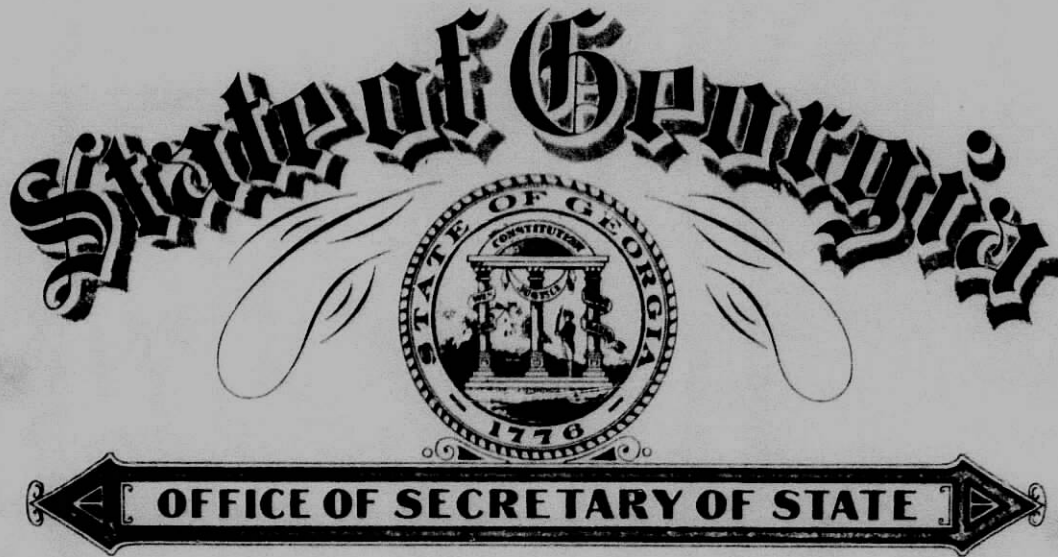

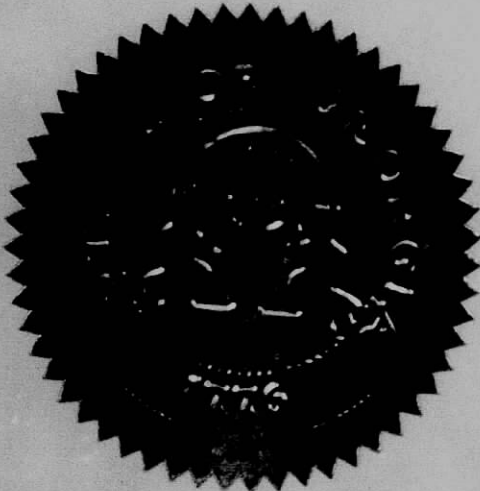
