CERTIFICATE OF LIMITED PARTNERSHIP

OF

STATION EIGHTY L.P.

The undersigned, for the purpose of forming a Limited Partnership pursuant to the provisions of the Uniform Limited Partnership Act of the State of Georgia hereby adopts the following:

I

The name of the Limited Partnership is "STATION EIGHTY L.P."

II

The Partnership shall be dissolved on December 31, 2030 unless otherwise dissolved by the happening of events outlined in the Partnership Agreement.

III

To buy or otherwise acquire, own, hold, manage, sell, exchange, lease, rent, develop, improve, mortgage, pledge, encumber or deal in and dispose of real estate or any interest therein.

In general, to carry on any other business connection with the foregoing and to have and exercise all powers conferred by the laws of the State of Georgia upon Partnerships formed pursuant to the Uniform Limited Partnership Act of the State of Georgia.

IV

The original capital of the Limited Partnership shall be FIVE HUNDRED (\$500.00) DOLLARS, which shall be contributed by the partners in their appropriate ownership percentages.

V
