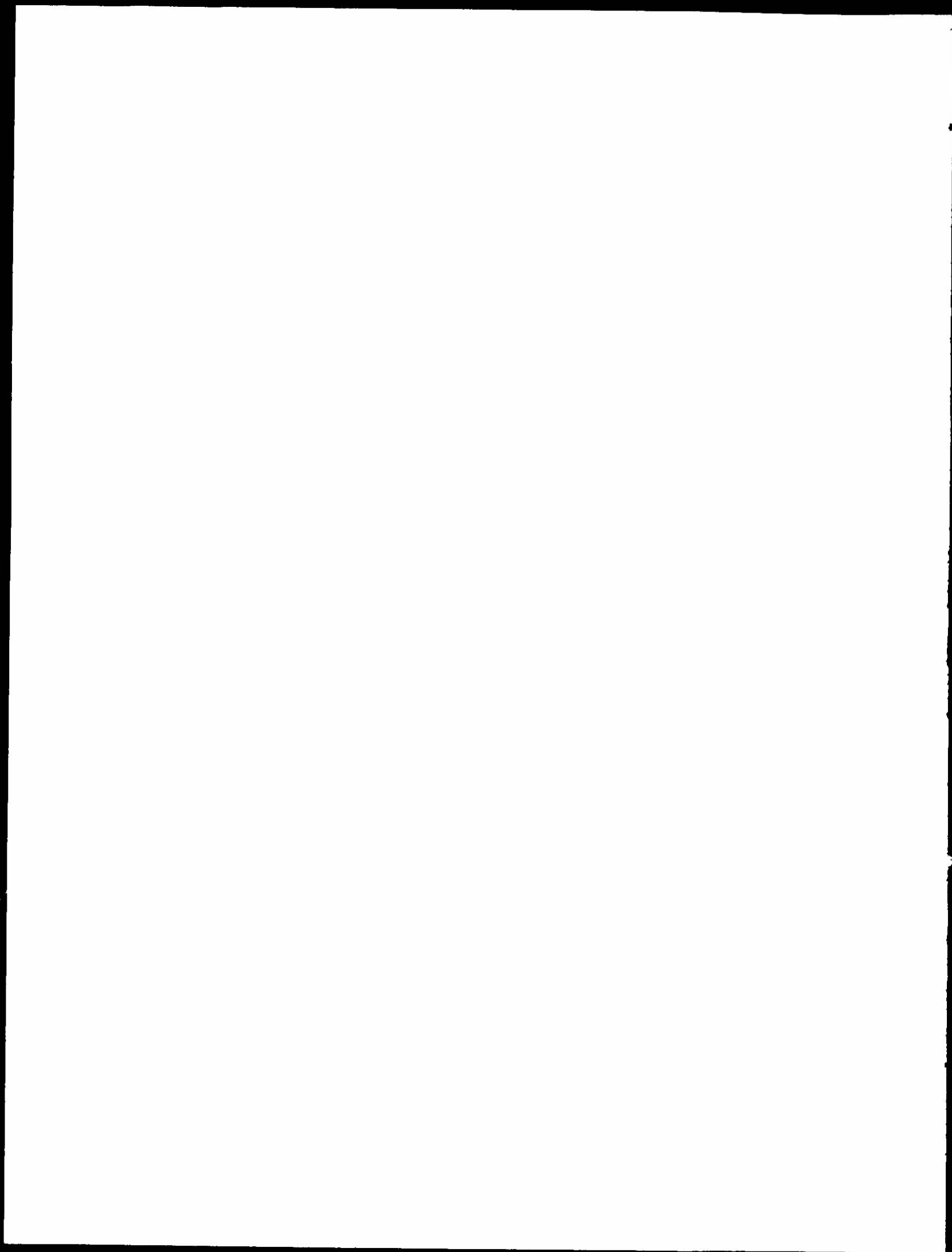

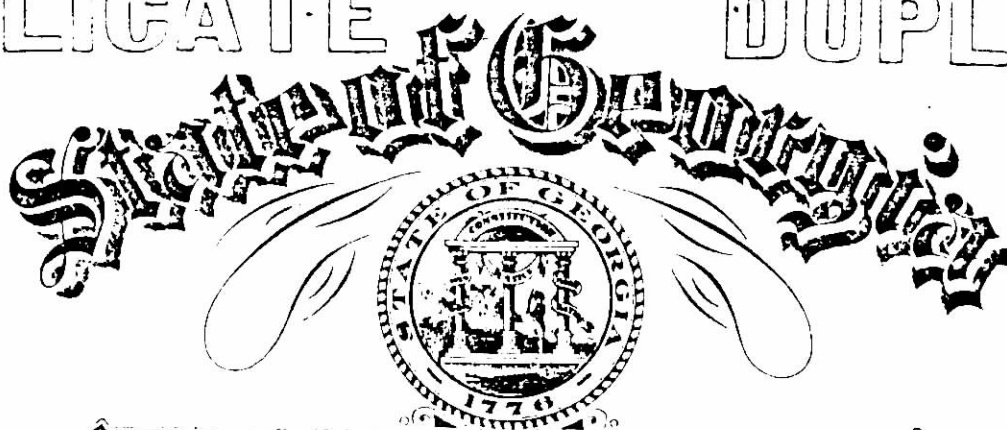

ARTICLES OF INCORPORATION
OF
DATA MANAGEMENT, INC.

I.

The name of the Corporation is Data Management, Inc.

II.

The Corporation shall have perpetual duration.

III.

The Corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

IV.

The Corporation is a corporation for profit and is organized for the following purposes: Sales, services, manufacturing, real estate acquisition and development, investment, and to engage in any other lawful business and activity for profit.

V.

The Corporation has the authority to issue not more than 10,000 shares of common stock having a par value of \$1.00 per share.

VI.

The Corporation shall not commence business until it shall have received not less than \$500.00 in payment for the issuance of shares of stock.

VII.

The initial registered office of the Corporation shall be 2911 Cole Court, County of Gwinnett, Norcross, Georgia 30071. The initial registered agent of the Corporation at such address shall be Drew M. Davidson, Jr.

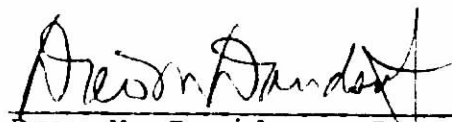

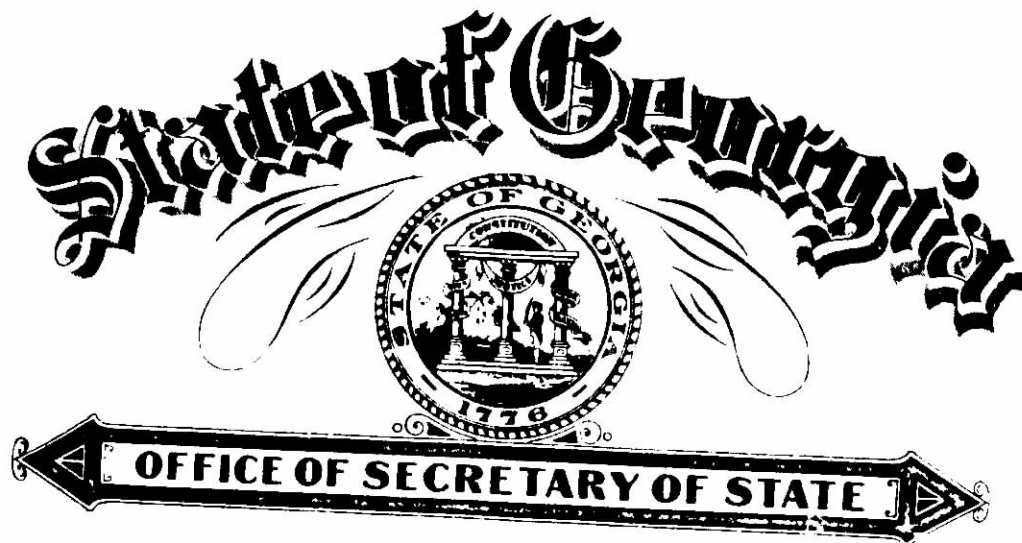
