**ARTICLES OF INCORPORATION OF
CRISIS PREGNANCY CENTER OF DOUGLAS COUNTY, INC.**

1.

The name of the Corporation is:
CRISIS PREGNANCY CENTER OF DOUGLAS COUNTY, INC.

2.

The Corporation shall have perpetual duration.

3.

The Corporation is organized pursuant to the provisions of
the Georgia Non-Profit Charitable Business Corporation Code.

4.

The specific purpose of this corporation is to help a
pregnant woman, who is in a state of crisis, to understand and
work through the alternatives, so that she may make an informed
decision concerning the outcome of her pregnancy. For the woman
who decides to carry her baby to term, the center will provide
emergency aid in whatever form is available and needed.

5.

This corporation is organized and operated exclusively
for charitable purposes within the meaning of Section 501 (c) (3)
of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on any propaganda or publicity campaign to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

The initial registered office of the Corporation shall be 2080 Fairburn Road, Suite A-2, Douglasville, GA 30135. The initial registered agent shall be Mrs. Esther Hunter and her

consent of the registered agent to serve in that capacity, as attached hereto.
