ARTICLES OF INCORPORATION  
OF  
WATT COMMERCIAL SWEEPING, INC.

The undersigned incorporator hereby submits the following Articles of Incorporation:

ARTICLE I

The name of the corporation is "WATT COMMERCIAL SWEEPING, INC."

ARTICLE II

The corporation shall be authorized to issue one hundred thousand (100,000) shares of common stock, without par value.

ARTICLE III

The initial registered office of the corporation shall be Eight Piedmont Center, Suite 210, Atlanta, Fulton County, Georgia 30305. The initial registered agent at such address shall be Benjamin H. Pruett.

ARTICLE IV

The mailing address of the initial principal office of the corporation shall be 2197-E Lake Park Drive, Smyrna, Cobb County, Georgia 30080.

ARTICLE V

To the extent allowable pursuant to O.C.G.A. §14-2-202(b)(4) and (b)(5), as they now exist or may hereafter be amended, no directors of this Corporation shall be personally liable to this Corporation or its shareholders for monetary damages for any breach of duty of care or other duty as a director. No amendment or repeal of this Article shall apply to or have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior to such amendment or repeal.

In discharging the duties of their respective positions and in determining what is believed to be in the best interests of the Corporation, the Board of Directors, committees of the Board of Directors, and individual directors, in addition to considering the effects of any action on the Corporation or its shareholders, may consider the interests of the employees, customers, suppliers, and creditors of the Corporation and its subsidiaries, the communities in which offices or other establishments of the Corporation and its subsidiaries are located, and all other factors such directors consider pertinent, provided, however, that this provision shall be deemed solely to grant discretionary authority to the directors and shall not be deemed to provide to any constituency any right to be considered.

ARTICLE VI


